
ABOUT SHIMLA NURSING COLLEGE

How to apply?

The prospectus along with application forms is available in the college office on remittance of Rs. 300/- by cash or Demand Draft in favor of "Shimla Nursing College" or students can apply through online mode also.

Eligibility for Admission to the M. Sc Nursing Post Graduate Degree Course:-

Admission to M.Sc. Nursing Degree course shall be made on the basis of merit of the Entrance Test to be conducted by the Atal Medical & Research University- Ner Chowk, Mandi, HP for which female candidates are eligible subject to fulfilment of the following conditions:-

- a) The candidate must have passed 10+2 and its equivalent examination from recognized Board/University established by Law in India with minimum 45% aggregate marks. For SC/ST/OBC candidates the required percentage of aggregate marks will be 40%.
- b) The candidates should be registered as registered Nurse/Midwife (RN/RM) B.Sc/Post Basic B.Sc Nursing with H.P State Nurses Registration Council Shimla/ Any State Nursing Registration Council at the time of counselling.
- c) The candidates should be B.Sc. Nursing /Post Basic B.Sc. Nursing /B. Sc Hons. Nursing trained from the recognized Institutions not less than 55% aggregate marks.
- d) Minimum one year of work experience after Basic B.Sc. Nursing on the last date of submission of application form.
- e) Minimum one year of work experience prior or after Post Basic B.Sc. Nursing on the last date of submission of application form.

The entry age of candidates should be 17 years as on 31st December, of the admission session and there is no upper age limit. The candidates will ensure that they must fulfil the above condition. Age as recorded in the matriculation certificate will be entertained.

Eligibility for Admission to the Post Basic B. Sc Nursing Undergraduate Degree Course: -

1. Admission to Post-Basic B.Sc. Nursing Degree course shall be made on the basis of merit of the Entrance Test to be conducted by the Atal Medical & Research University- Ner Chowk, Mandi, HP for which the female candidates only are eligible subject to fulfilment of the following conditions:-

a) The candidates should be registered as registered Nurse/Midwife (RN/RM) with H.P State Nurses Registration Council, Shimla at the time of counselling. Provided further that the candidates belonging to another states of the country should be registered in their respective State Nurses Registration Council and at the time of Counselling, they must produce NOC for pursuing their higher studies outside the state from the Registrar of the concerned State Registration Council.

b) The candidate must have passed 10+2 and its equivalent examination from recognized Board/University established by Law in India with minimum 40% aggregate marks. For SC/ST/OBC candidates the required percentage of aggregate marks will be 35%.

c) The candidate must have obtained 50% marks in General Nursing & Midwifery from the School/Institution recognized by the Indian Nursing Council/Himachal Pradesh Nurses Registration Council.

d) The distribution of seats between In-Service and Direct candidates will be made in the ratio of 70:30. However, 200 point vertical reservation roster will be applied afresh for distribution of seats among General, SC, ST and OBC categories and no horizontal reservation roster will be applied.

The entry age of candidates should be 17 years as on 31st December, of the admission session and there is no upper age limit. The candidates will ensure that they must fulfill the above condition. Age as recorded in the matriculation certificate will be entertained.

Eligibility for Admission to the B. Sc Nursing Undergraduate Degree Course: -

1. (i) Female Children of Bonafide Himachali/Domicile/Himachal Govt. employees and employees of Autonomous bodies wholly or partially financed by the Himachal Pradesh Government will only be eligible to apply for admission to 4 years B.Sc. Nursing Degree Course through Entrance Test to be conducted by Atal Medical & Research University- Ner Chowk, Mandi, HP in Sister Nivedita Govt. College of Nursing, IGMC, Shimla and Private un-aided B.Sc. Nursing Colleges/Institutions situated in the State of Himachal Pradesh.

(ii) For filling up of 50 % Management Quota Seats in Private un-aided B.Sc. Nursing Colleges in State of Himachal Pradesh, there will be no domicile requirement. Under this quota, both Himachali and Non-Himachali interested candidates can compete in the entrance test subject to fulfilments of minimum educational qualification and age etc. as prescribed in the prospectus.

Note: The above candidates should be Indian National.

2. The entry age of candidates should be 17 years as on 31st December, of the admission session and there is no upper age limit. The candidates will ensure that they must fulfill the above condition. Age as recorded in the matriculation certificate will be entertained.

3. Admission to married candidates will be allowed subject to production of medical fitness certificate.

4. A candidate should have passed 10+2 or its equivalent examination from H.P. Board of School Education/AIISCE/CBSE/ICSE/SSCE/HSCE or any other Board/University established by law in India in the subjects of Physics, Chemistry, Biology and English individually and with 45% marks taken together in Physics, Chemistry and Biology at the qualifying ex-

-amination. The candidates belonging to SC/ST/OBC, the marks obtained in Physics, Chemistry and Biology taken together in qualifying examination will be 40% instead of 45% as stated above. Provided further that English is a compulsory subject in 10+2 for being eligible for admission to B.Sc (Nursing) course. The candidate should be medically fit.

5. The candidates who appeared in 10+2 examination and their result are not yet been declared may also apply for this test, but their admission will be made, if they fulfil the minimum eligibility criteria as prescribed in the prospectus at the time of 01st round of counselling.

Note:

(i) *The candidates who have passed their 10+2 examination from National Institute of Open School or appeared in 10+2 examination Science (Medical) conducted by National Institute of Open School can also apply to this test.*

(ii) *The above qualifications will only determine the eligibility of a candidate for admission, but the actual basis of admission shall be on the basis of marks obtained by the candidate(s) in the Entrance Test.*

Physical Fitness

Besides fulfilling the eligibility conditions, the candidate should be certified by Govt. Medical officer/Registered Medical Practitioner as physically and mentally fit to pursue the course.

Eligibility for Admission to the GNM Course

1. Minimum education eligibility criteria for admission to GNM:

- 10+2 with 40% marks from any recognized board. However Science is preferable

- Candidates are also eligible from State Open School recognized by State Government and National Institute of Open School (NIOS) recognized by Central Government.
- 10+2 Health care Science – Vocational stream from a recognized CBSE board/State/Centre

2. Admission of students shall be once in a year.

3. Students shall be medically fit.

4. Age- Minimum entry age for admission will be 17 years. (As on 31st December of that year) and there is no upper age limit. The candidates will ensure that they must fulfill the above condition. Age as recorded in the matriculation certificate will be entertained.

Documents to be submitted on Admission:

The following certificates will be submitted by the candidate at the time of admission: -

- a) Self-Attested copies of Detailed Mark Certificates of 10th/10+2/B.Sc-N/PBB.Sc-N/GNM qualifying examination and other higher examination passed by the candidates.
- b) Diploma/Degree of the last examination passed along with registration certificate of the course.
- c) Character/Conduct Certificate issued by a Gazetted Officers (Tehsildar/SDM) and Head of the Institution (Principal) last attended.
- d) Certificate of Bonafide Himachali or resident certificate of the concerned state.
- e) Original Migration Certificate from the board/university from which the candidate has passed her last examination.
- f) Category/Sub-Category Certificate against which selected i.e. OBC/SC/ST/IRDP/Ex-Service-men/WFF/PH.
- g) Anti-Ragging undertaking by the Student and Guardians on plane papers for later online mode submission.
- h) 5-6 Passport Size Photograph.
- i) Medical Fitness Certificate
- j) Adhar Card Copy
- k) College rules & regulations declaration/affidavit

NOTE: There is no provision of migration from one private institution to another private institution or from private institution to the Govt. institution.

Method of Selection

- I. Eligible candidates will be called before the selection committee specially constituted for the purpose of counseling (verification of documents).

II. Management reserve the right to select or reject any candidate without assigning any reason whatsoever.

Syllabus for all the four (04) running nursing courses i.e M.Sc-N/B.Sc-N/PBBSc-N & GNM will be followed as per the Indian Nursing Council norms

EXAMINATION

- Annual examination of M.Sc-N/Post Basic B.Sc-N & Semi-Annual Examination of B.Sc-N will be conducted and respective Degree will be awarded by Atal Medical & Research University-Ner-chowk, Mandi- HP.
- Annual examination of GNM is conducted and Diploma for GNM will be awarded by Himachal Pradesh Nurses Registration Council, Shimla.

Eligibility for Admission to Examination

A candidate must have minimum of 80% attendance of Theory and 100% attendance in each of the practical areas.

Note:

- A candidate has to pass in theory and practical exam separately in each of the paper.
- Minimum pass marks shall be 50% in each of the theory and practical separately.
- If candidates fail in either theory or practical paper, she has to re-appear for both the papers (theory and practical)
- Maximum number of attempts permitted for each paper is 3 including first attempt.
- The student shall be required to maintain the Practical record book and report of observation visits and diary for assessment must also be used.

ANTIRAGGING MEASURES

AS PER THE HIMACHAL PRADESH EDUCATIONAL INSTITUTIONS (PROHIBITION OF RAGGING) ANTI RAGGING ACT 2009, RAGGING IS COMPLETELY PROHIBITED. Also, as per direction of the **Honorable Supreme Court of India**, the Government has banned ragging completely in any form inside and outside the campus and authorities are determined not to allow any form of ragging. Whosoever directly or indirectly commits, participates in, abets or instigates ragging within or outside Shimla Nursing College shall have an FIR lodged against her and she will be suspended or rusticated from the Institute and shall also be liable to be fined which may extend to **Rs. 10,000/-**. In case the applicant for admission is found to have indulged in ragging in the past or if it is noticed later that she has indulged in ragging, admission can be refused or she shall be expelled from the Institute. The punishment may also include suspension from attending the classes, withholding/ withdrawing fellowship and other financial benefits or withholding the result.

1. No person shall indulge in ragging in any form, within or outside the premises of an educational institution.
2. Any person if on *prima facie* evidence is found guilty will be suspended from the educational institution.
3. On conviction be punished with imprisonment for term which may extend to 3 years or with fine which may extend to fifty thousand rupees or with both.
3. Every offence under this act shall be cognizable, non-bailable and compoundable with the permission of the court.
4. Any student convicted of an offence under this act will be expelled from the educational institution.

5. Student expelled under sub-section (1) or expelled otherwise on account of ragging shall not be admitted in any other institution for a period of three years from the date of order of such expulsion.

6. Notice/Circular for prohibition of Ragging shall be available on:

- Notice Boards
- Admission Brochure/Prospectus

7. Display Posters/Charts on Prohibition of Ragging in common places.

8. Constitute: -






for storage of food items. The food items shall be purchased for the conduct of practical classes as and when required. Sets of crockery and cutlery for preparation, napkins for serving and display of food also available there.

b) Community Health Nursing Lab:

This Lab is well designed and equipped with articles for preparing students to work in Urban and Rural areas in field of community. This lab ensures the students to learn home visiting, bag technique & practice the Community Health Nursing while providing family health care at the door step of the client using modified home visiting.

c) Nursing Foundation Lab:

Lab well ventilated fully equipped with demonstration beds with dummies, mannequins in proportion to the number of students practicing a nursing procedure at a given point of time, built-in-cupboards and racks, wash-basins with running water supply, electric fitting, adequate furniture like table, chairs, stools, patient lockers footsteps etc. Sufficient Necessary inventory articles needed for the practice of nursing procedure by the students.



d) OBG and Pediatric Nursing lab/ Maternal and Child Health Nursing Lab:

e) Pre-Clinical Science (Anatomy and Physiology & Microbiology) Lab:



5) Hostels


RULES AND REGULATIONS FOR GIRL'S HOSTEL

The following rules shall apply to FEMALE students residing in the nursing hostels of Shimla Nursing College. Violation of any rule will make the inmate liable to disciplinary action including expulsion from the hostels and also from institution: -

1. Every student must remember that the hostel is the home of the student on the campus and therefore, she should behave himself/herself on the campus as well as outside in such a manner as to bring credit to her and to the institution.
2. A student once admitted in the hostel will continue to be a hostel inmate throughout the course unless otherwise debarred from the hostel on disciplinary grounds. Unless they clear the dues, they shall not

be allowed to take University examinations. Further, she may be expelled from the halls of residence and/or messes.


3. All the student are instructed to use cell phone during mentioned hours as prescribed by the college authority time to time (at present 6-4pm). If any student found using phone other than mentioned time, their phones will be taken by the authorities and also will be fined Rs. 200/- minimum.
4. Parents are instructed to call in college and hostel in mentioned hours only i.e College – 10 am - 4 pm & Hostel -6pm -7pm.
5. Hostel inmates are requested to maintain their surroundings neat and clean.
6. It is mandatory for students residing in the Hostel to join the mess attached to the hostel. Hostellers are required to dine in the dining hall. No hosteller is permitted to take food in the room except for those reported sick with prior permission of hostel warden. Indoor cooking including making of tea/coffee/noodles in the rooms is strictly prohibited. The hostellers shall not waste food, electricity & water. Wastage of food is a national loss.
7. Every student residing in the hostel must dine in the hostel messes only. Individual/group cooking in the rooms is forbidden. If found, they will be expelled from hostels or fined. Cooking in hostel rooms is not permitted. All instructions/ notices displayed on notice boards will be deemed to have been read by all residents and excuses for non-compliance of such instructions and notices will not be accepted. Residents are advised to look at the notice board every day to acquaint themselves with latest information/orders.
 - ↳ Hostel students shall not leave the headquarters without prior permission of the Warden /Chief Warden. They shall have to apply for permission in writing in advance stating the reason for leaving and the address of destination. Hostel students who leave hostel without the application and prior permission from the concerned authorities shall be deemed to be missing and their parent/guardian or even the police authorities may be intimated.
 - ↳ Accommodation in the hostel cannot be claimed as a matter of right. Students who disturb peace and violate the rules of the hostels on the campus will be expelled from the hostels.
10. Visitors are not permitted in the hostel after 6.00 p.m. However, in special cases, prior permission of warden must be obtained to stay beyond these hours.



11. No parent or guardian of a student is permitted to stay in the hostel. They must obtain prior permission from the Principal/College authority to stay in the college Guest House only, (if such accommodation is available for a specific period on payment basis as per the Guest House accommodation rules).
12. Any hostel student harbouring any unauthorised person(s) will be expelled from the hostel immediately. Residents returning late to their Hostels will be fined. The HOIs and Parents of residents coming very late or who are habitual offenders will be informed. In acute cases the resident may have to vacate the Hostel
13. No association of students on the basis of region, caste or creed is permitted. No secret activities or meetings are permitted on the hostel premises. For holding any meeting in the hostel room or anywhere in the hostel area, prior written permission should be obtained from the principal
14. No resident of the hostel is permitted to take any article/utensils etc, outside the hostel /mess premises and even to his/her room. No one should use the belongings of other students without their consent.
15. The hostellers are neither allowed to keep private electrical equipment nor would tamper with electrical fittings provided in rooms. Unauthorized possession will lead to confiscation of the goods. Each student shall use only one tube-light not exceeding 40 watts. Use of all unauthorised electrical appliances such as heaters etc., is strictly prohibited and these will be confiscated, and the concerned student will be penalised. However, usage of computer and printer in the hostel room will be allowed with prior permission from the Chief Warden. Fans and lights must be switched off when the students leave their rooms. Light must be switched off positively when they go to bed. In case it is noticed that fans/lights are on the locked room, a heavy penalty will be imposed for wasting the costly energy sources. No televisions are permitted to be kept in the hostel rooms by the students. Students have to watch TV in the common TV room provided in the hostels.
16. The Chief Warden/ Warden or his representative may enter any room for verification at any time of the day or night. The room of any student in the hostel can be inspected at any time by the Warden/Chief Warden or any authorised member of the institute staff or district police officials. Inmates are advised to keep their ID cards with them and show them on demand.

17. The hostellers themselves are personally responsible to safeguard their belongings. They are advised not to keep large amounts of cash or valuables like gold ring, costly wristwatch etc., in their rooms. They should also take care of their Purse, Calculators, Cell Phones, Lap tops, and Books. In case of theft or loss of any item the hostel authorities/institute will not be responsible for such loss. The hostellers are advised to keep their boxes, suitcases, cupboards, etc., securely locked with good quality locks. They are advised to deposit extra cash in the bank or in the post office or at any other safe place. All residents must take care of their ATM/ Debit cards. They must not disclose their PIN to anybody- even to their best friends

18. The residents are forbidden to keep any heavy cash/ valuables in the room. The resident is responsible for the safety of his/her items inside the rooms. Giving the room keys to any person (except the Block Supervisors/ Caretakers/ Wardens) in good faith is at their own risk. The management will not take any responsibility for any loss of such costly articles /money. They may deposit all sums of money not immediately required by them for their expenses in the local Banks. The residents must lock the rooms and their lockers with their own locks.



19. Keeping of lethal weapons like sticks, rods, chains etc. in the hostel rooms is strictly prohibited. The hostel cannot be considered as the hiding place for miscreants. The police authorities may enter the campus and detain anyone depending upon the severity of the offence.

20. The consumption or storage or supply of liquor, smoking or any sort of intoxicant like chewing of tobacco etc., use of drugs and narcotics and even possession of such things is strictly prohibited and if found guilty, the offenders will be dealt with severely, including prosecution like rusticated from the institute. Any kind of gambling is also prohibited. Playing music and videos etc. inside the rooms is strictly prohibited as it causes disturbance to the inmates. Any such complaint against boarders will be viewed very seriously and seizure of the gadgets will be made along with imposition of heavy fine.

21. Anything which interferes with student's studies must be avoided at all times. No noise of any sort will be permitted in the hostel. Serious action will be taken on the breach of this rule. Residents must not

go to others" rooms and disturb the inmates. Complaints from other residents will be investigated and action taken accordingly.

22. All complaints regarding repairs/maintenance in the Hostels must be entered personally by the students in „Complaint Registers" maintained in all the Hostels. These complaints are attended to expeditiously by MSFM staff. All complaints are also monitored regularly by the Warden/Chief Warden.

23. Ragging in any form is banned inside and outside the campus. Strict action will be taken against the defaulters. No leniency will be shown to the offenders. Suspension and or withdrawal from the hostel/college is one of the actions taken promptly. Ragging of any kind is severely punishable as per the HIMACHAL PRADESH State Prohibition of Ragging Act, 1997 and 2002. As such students are advised not to indulge in such activity. Punishment for ragging under the Karnataka education act of 1983 can be up to one year imprisonment. Supreme Court has also defined ragging as a criminal offence. 24. Medical facilities are provided at the college First Aid Box for routine health problems. However, for any other treatment requiring specialist/expert medical care and treatment, the inmates are supposed to make their own arrangements for treatment and to bear medical expenditure themselves. In case a student falls sick, he/she should contact immediately the Chief Warden. In case of an emergency, student may shift the patient immediately to a hospital and inform the authorities at the earliest. A student suffering from infectious/contagious diseases will not be permitted to stay in hostels.

25. Boarders will be personally and collectively responsible for any loss/damage to the properties and equipment and other fittings in the common halls. Students should not break open or try to break open the occupied/vacant rooms of the hostels..In case of damage to any buildings, furniture, apparatus or other property of the college, the loss caused to the institution shall be recovered directly from those identified persons whenever possible. But, if persons who cause the damage are unknown, the cost of repairing it, as may be assessed by the hostel authorities, will be distributed equally among all the students of such groups or associations as may be found responsible.

26. No hostel inmate shall take the law into her own hands. If any of the hostel inmates find that other students are indulging in any undesirable activity or causing inconvenience or

physical injury to her or to the other hostel inmates, she should lodge a complaint in writing with the warden concerned. Hostel inmates who are found guilty of misconduct or guilty of infringement of any of the rules prescribed above shall be liable to fine, suspension, rustication or dismissal either from the hostels and/or from the institute or both by the appropriate authority.

27. The entry of all males is strictly forbidden inside girl's hostel except on university official duty with valid passes. Likewise, girls are not permitted to enter the gents' hostels.

28. Students who have finished the course work but yet to pass some examinations are called backloggers. Such students will not be normally given accommodation in the college hostels. Similarly, students who have not been promoted to the next higher class and who are not for some reason attending classes during the given semester or academic year also will not be given accommodation in the hostels.

29. Washing clothes inside the hostel premises is completely prohibited. Wards should give clothes to the washer man for washing clothes.

COLLEGE RULES AND REGULATIONS



1. Pay your college/ hostel dues as per the prescribed schedule (dates fixed by the college) & notified time to time by the college. Delay in payment beyond due dates will be fined accordingly and consider with late fees only (Minimum ₹50 to ₹200).

2. The fee/fine and other dues once paid are Not Refundable, Negotiable under any circumstances.

3. Annual DMC's, Course Completion & Relieving Certificate of the students will be issued only after the clearance certificate of all the college/hostel/transportation funds/fine paid by the student for the entire course duration. Students must keep their all the fees paid record ready in case of any conflicts.

4. In case of any breakage of equipment, material either in Hospital, Hostel, Demonstration room, Laboratories etc. concerned students has to bear the cost of the breakage.

5. If the applicant leaves the college before completion of the course, no fee would be refundable, negotiable under any circumstances and students has to pay full amount of the course duration fee along with hostel rent, transport as well as other college fees etc.

6. The management, administration of the college has the right to change the fee structure the college fee/funds at any time if required & we shall abide by the changed structure.

7. During the entire course of training period, the applicant will not marry, and if already married will not conceive /get pregnant.

↳ No mobile phones are allowed in the college.

- ↳ The applicant will not get involved in any kind RAGGING ACTIVITIES if involved will be punished as per the guidelines and laws of state and Central Government, which may mean rustication from the college.

10. There is a water problem or shortage in Shimla. So, Students can face this problem in college or hostel.

11. Mess menu can have slight changes in the week but ensuring the abiding of the menu made by wards.

12. Leaves are to be sanctioned in urgent situations i.e. Regarding death, any serious illness and a person can avail her ten leaves in that regard. Other leaves will be sanctioned only if student have 90% attendance and any correspondence from parent's side is done.

13. All the students have to be deposited the imposed fine within stipulated time period of two days. Otherwise, strict action will be taken resulting in suspension etc.

Policy for the students who leave college mid-session due to genuine Personal/ Health reasons.

Withdrawal Policy for Mid-Session/Term of the Course.

Purpose

To outline the procedures and implications for students who withdraw from Shimla Nursing College mid-session due to personal reasons, will have to define a solid purpose i.e health, family problem with concrete evidence to support the same , which will be evaluated by the administration/ college authorities and if found satisfactory, mid-session withdrawal can be permitted .

Eligibility

Students once enrolled in any degree/ diploma course are not entitled or cannot leave mid-session as laid out in the prospectus of the college and the submissions made thereof, it will only be considered in cases which are beyond reasonable control, grave, medical urgencies and where effort was made to reconcile attend college but still faced circumstances requiring them to leave for their well-being at the end of session. Under no circumstances college change would be accepted or migration allowed mid-session.

Procedure for Withdrawal

Notification: Submit a written request to the college administration prior to 30 days minimum before leaving, will detailing the reasons for withdrawal at the end of session. Immediate approach to leave will not allowed.

Meeting: Attend a meeting with a counselor or academic advisor as notified by the college to discuss the decision and explore alternatives which are in the best interest of the students for a fulfilling professional career.

Documentation: Provide all necessary documentation to support the reason for withdrawal to the administration which after scrutiny and if found satisfactory by the administration / authorities the student will be informed accordingly. It would only be allowed for grave medical or personal problems (e.g. medical certificates and reports).

Financial Implications

Academic College Fee Refunds: Academic College fee once paid will not be refunded under any circumstances. On the contrary the student will have to pay the entire pending academic college fee as notified by the college administration for all the future period of the program enrolled. The college will take a declaration (affidavit) by the parent/guardian at the time of the admission to have read the mid-session withdrawal rules and guidelines and fully abide by them. The parent will have to give a security and surety in form of a blank Cheques / Pledged FDR, CDR / Demand Draft deposited as per the security or surety protocol defined by the college taken at the time of the admission. Hostel, mess and transport refund eligibility will be based on the college's refund schedule, which considers the date of withdrawal.

Outstanding Fees: Settle any all outstanding fees (college/hostel/mess/transp./uniform/books/misc. etc.) or financial obligations to the college for the academic year in progress and notified as per the college fee for the future years of the enrollment in the particular course .

Academic Records

Transcripts: Courses attended up to the date of withdrawal will be recorded on the transcript. Grades or a "W" (Withdrawal) may be assigned based on the timing of the decision.

Credits: The administration will determine how credits for completed coursework will be handled at the end of the semester or session as applicable and would be given subject to clearance of all dues.
